Editorial: The Gate of The Year

"And I said to the man who stood at the gate of the year: 'Give me a light that I may tread safely into the unknown.'

And he replied:

'Go out into the darkness and put your hand into the Hand of God. That shall be to you better than light and safer than a known way.'

So I went forth, and finding the Hand of God, trod gladly into the night. And he led me towards the hills and the breaking of day in the lone East."

This is the opening stanza of a poem written by Minnie Louise Haskins in 1908. In 1939, the then-Princess Elizabeth gave it to her father, King George VI, and he quoted it in his Christmas broadcast to the British Empire that year.

While these words may have been considered appropriate for a war-time Christmas broadcast, they seem to be even more fitting for us in The Salvation Army at the start of a new year. As we think about the challenges that face us as we attempt to meet the needs of all those who will depend on us during 2016, may this poem inspire us, both in our work and our personal lives.

The Salvation Army Receives Imagine Canada Accreditation

The Salvation Army has received Imagine Canada accreditation! We are the first religious denomination to secure this – a significant achievement, particularly in light of the Army's most diverse ministries.

In our October 15, 2014 issue, we wrote about what the accreditation process involved and why it was important to pursue it. With the introduction of a standards program by Imagine Canada in 2012, charities no longer just "sign on" to their Ethical Fundraising & Financial Accountability Code. It became a matter of living the code and demonstrating that the principles within the code were operational. The Governing Council agreed that the Army needed to meet Imagine Canada's standards which represent best practices in fundraising and financial accountability.

The accreditation designation means meeting 73 standards across the five areas listed below. We have indicated in brackets which Army entity has primary responsibility for an area.

- 1. Board Leadership (Governing Council)
- 2. Financial Accountability & Transparency (Finance Department)
- 3. Fundraising (Public Relations & Development Department)
- 4. Staff Management (Employee Relations Department)
- 5. Volunteer Management (multiple)

The process involved substantial work over 2 ½ years. The accreditation, which will soon be announced by Imagine Canada, provides the Army with an accreditation for five years during which period there will be periodic compliance check-ins.

Going forward, the Finance Department will be reviewing our submission to Imagine Canada in order to develop strategies that will enable us to improve our practices wherever possible. This will also help us to be well prepared for the next accreditation process, in 2021.

It is timely that our accreditation parallels General Cox's call to greater accountability and transparency within The Salvation Army internationally. In a recent meeting of South Asia leaders, he said:

"We all have to be accountable for the decisions we make and for the way in which we use the assets of the Army. We must never forget that we do not own the Army's assets personally. We are but custodians of assets entrusted to The Salvation Army by God."

We are pleased to be able to support the General's call through Imagine Canada's accreditation. It is a practical step that provides tangible evidence of our accountability. As we affix the accreditation seal to our website and publications, we trust it will be another reason for the public to continue to have confidence in The Salvation Army's stewardship.
