focusing on four key areas in the fight against modern slavery and human trafficking. Here's our Strategy...

**1 Awareness and Training** – Effective and intentional awareness, education, and training is needed to mobilize people within the territory to fight against human trafficking.

*Here are some things we are going to focus on:*

- Developing and implementing human trafficking training for officers, employees, volunteers, cadets, and those connected to our corps and ministry units.
- Developing identification tools and resources to help us identify the signs, risks, and methods of human trafficking.
- Developing and implementing human trafficking awareness and training materials that engages every level within our territorial structure. This includes: emergency disaster services, thrift stores, children and youth, family services, shelters, corps, etc.

**2 Prevention and Outreach** – We believe that it is possible to prevent modern slavery and human trafficking and that The Salvation Army is strategically positioned as an organization across Canada and Bermuda to help do so.

*Here are some things we are going to focus on:*

- Integrating human trafficking awareness, tools, and resources into our ministry units and programming that serves vulnerable people groups.
- Encouraging and mobilizing corps to engage in coordinated human trafficking outreach within every division.
- Developing further prevention initiatives that focus on the demand and the trafficker.

**3 Survivor Services and Recovery** – Once survivors of sex and labour trafficking have escaped months or years of victimization, they will need diverse and holistic services that recognizes the unique trauma they have experienced as they work to rebuild their lives. These services may include supports such as immediate housing, counselling, medical care, legal advocacy, food and clothing assistance, etc.

*Here are some things we are going to focus on:*

- Establishing more residential first stage safe houses across the territory.
- Establishing more short-term and long-term beds across the territory for both female and male victims and survivors.
- Developing and implementing holistic, trauma informed, victim-centered programming and initiatives for survivors.

**4 Partnership and Advocacy** – We can't do this on our own if we want to make any real, long-lasting impact in our human trafficking efforts. We need to intentionally stand and collaborate with others to advocate and fight against it.

*Here are some things we are going to focus on:*

- Participate and collaborate on local human trafficking task forces.
- Establish strategic partnerships with local, provincial, and national human trafficking organizations.
- Engage in advocacy regarding identified key areas of policy, laws, and specific cultural issues.



This is a significant issue, not only around the world but in Canada and Bermuda.
